### E-Rate Exchange Service Agreement Category Two Filing

RESOLVED that, upon the recommendation of the Superintendent of Schools, the Board of Education does hereby approve the proposal for E-Rate Category Two filing services in an amount of 3% of reimbursed funding plus a fee of \$500 from E-Rate Exchange, LLC for the 2015 funding year; and

BE IT FURTHER RESOLVED, that the Board hereby authorizes the Board President to execute the agreement between the District and E-Rate Exchange, LLC. A copy of such agreement shall be incorporated by reference within the minutes of this meeting.

## Tax Certiorari

On motion by Mr. Haberman, seconded by Mr. Satran, and passed 4-0, it is hereby

RESOLVED, that the Board of Education does hereby authorize the refund of taxes in the amount of \$20,193.98 due for the property with tax identification number 98.10-1-6 as required by the terms of the Consent Judgment.

BE IT FURTHER RESOLVED, that the Board of Education does hereby approve an increase to budget line A1930.400 (Judgment and Claims) in the amount of \$6,130.42.

This expenditure represents tax certiorari refunds due for the 2008-09 school tax year in accordance with the terms of the Consent Judgment and will be funded from the Tax Certiorari Reserve.

Resolution to adopt the expedited material change to the District's APPR Plan Document for Classroom Teachers and Building Principals covered under Education Law Section 3012-c
On motion by Mr. Haberman, seconded by Mr. Satran, and passed 4-0, it is hereby

RESOLVED, that the Board of Education hereby adopts the Expedited Material Change to its Annual Professional Performance Review ("APPR") Plan for classroom teachers and building principals covered under Education Law Section 3012-c effective for the 2014-15 school year and thereafter, in accordance with the provisions of Education Law Section 3012-c(2)(l).

## Alternative Veteran's Tax Exemption

On motion by Mr. Haberman, seconded by Mr. Satran, and passed 3-1, it is hereby

WHEREAS, the Board of Education wishes to adopt the provisions of Section 458-a of the Real Property Tax Law which would grant a partial exemption from taxation for school district purposes of certain real property situated in the School District and owned and used as the primary residence by eligible veterans (Alternative Veterans' Exemption); and

NOW, THEREFORE, BE IT RESOLVED, that the Board, after having conducted a public hearing on <u>December 15, 2014</u> and having given the public an opportunity to be heard on the issue of the Board's proposed adoption of the Alternative Veterans' Exemption pursuant to Section 458-a of the Real Property Tax law, hereby adopts the Alternative Veterans' Exemption for assessment rolls prepared on the basis of the taxable status date occurring on or after January 1, 2014, at the following basic maximum levels:

- 1. Basic Exemption Tax exemption of 15% of the assessed value of the property, not to exceed \$12,000 or the product of \$12,000 multiplied by the latest state equalization rate for the assessing unit, whichever is less.
- 2. Combat Zone An additional tax exemption of 10% of the assessed value of qualifying residential property of veterans who are documented to have served in a combat zone, not to exceed \$8,000 or the product of \$8,000 multiplied by the latest state equalization rate, whichever is less.
- 3. Disabled Veterans In addition to the above exemptions, where the veteran received a compensation rating from the Veterans' Administration or Department of Defense based upon a service related disability, the qualifying residential property will be exempt to the extent of the product of the assessed

value multiplied by 50% of the veteran's disability rating, not to exceed \$40,000 or the product of \$40,000 multiplied by the latest state equalization rate, whichever is less; and

BE IT FURTHER RESOLVED, that the Board directs the District Clerk to provide a certified copy of this resolution to <u>Westchester County</u> and the assessors for the other taxing jurisdictions located within this School District.
