RESOLVED, that the Board of Education does hereby authorize the Superintendent of Schools to extend offers of employment too prospective District employees during the month of August 2011, with a start date on or after September 1, 2011, upon notice to the President of the Board of Education and subject to Board of Education ratification at its first public meeting in September 2011.
- b. RESOLVED, that the Board of Education does hereby approve the appointment of Georgette Shearer to a 1.0 FTE Probationary position in the tenure area of Science at the Middle School effective September 1, 2011 at the salary rate of MA Step 1. Mrs. Shearer is certified in Biology and Chemistry. Her tenure date is August 31, 2014.

- f. WHEREAS, the Board of Education wishes to continue with its field remediation activities related to the requirements of the New York State Department of Environmental Conservation's (NYSDEC) order on consent #20010816-113,

THEREFORE, BE IT RESOLVED that the Board of Education does hereby accept the proposal for providing field remediation estimates and landscape architectural services from Eberlin & Eberlin in the amount not to exceed \$3,000 in relation to the order on consent and an additional \$3,000 for other landscape architectural services (Total = \$6,000) and,

BE IT FURTHER RESOLVED, that the Board of Education authorizes the Assistant Superintendent for Business to transfer the sum of up to and including \$3,000 from the Property Loss and Liability Reserve Fund to the general fund to pay for the costs for field remediation estimates only and the District's continued field remediation activities.

- g. WHEREAS, the Board of Education previously established a property loss reserve fund pursuant to Section 1709(8-c) of the Education Law for the purpose of paying the costs associated with property loss claims and wishes to fund such reserve at the maximum level;

THEREFORE, BE IT RESOLVED, that the Board of Education hereby appropriates the sum of \$153,336.69 for such purpose from unassigned fund balance for the 2010-2011 school year and authorizes the Assistant Superintendent for Business to transfer such sum from 2010-2011 unassigned fund balance to the property loss reserve, to bring the total amount in such reserve to \$1,452,000.

- h. RESOLVED, that the Board of Education hereby approves the proposal from Pupil Benefits Plan Inc. through the NY Best Agency for K-12 student accident insurance in the amount of \$19,488.99 for the 2011-12 school year.
- i. RESOLVED, that the Board of Education hereby approves salary increases for managerial and confidential employees effective July 1, 2011, in accordance with the recommendations in a Memo from Stuart Matthey dated July 14, 2011, which memo is incorporated by reference and made a part of this resolution.
